All school and boarding fees are payable **in advance**. To accommodate parents, we offer **5%** discount on School Fees and **5%** discount on Hostel Fees if the annual fees are settled in full by the end of February. We also offer various payment options, as set out below.

VGHS FEES 2026: ADDITIONAL INFORMATION

At VGHS we strive not to burden our parents with additional requests for money, therefore many activities are included in the school and boarding fees. Kindly study information below and note new information

BOARDING FEES

- An additional fee of **R200.00** Boarders' Activities Fee to be used for entry to school and hostel events and activities. It is **not transferable** from one year to the next. This amount will be charged to the hostel account and is non-refundable.
- An additional fee of **R200.00** is payable towards the out of town excursions of every hostel. Parents will not be asked during the course of the year to contribute towards hostel excursions. This amount is non-refundable.
- The President's Award Programme: We encourage learners to participate in this program. Their mission is to "empower young people by providing a balanced, non-competitive framework for self-development that will increase their self-esteem and enhance their capacity to achieve in whatever context they find themselves". Participation in the programme will be monitored and encouraged by the hostel staff. Read more about it: www.presidentsaward.co.za. **Fees for President's Award Programme are not included in the Hostel or School Fees.**
- No exemption is available on hostel fees.**
- Hostel fees are payable in advance **BEFORE the first day of each term. Any boarder who has fees in arrears and has not paid in advance for the term will not be allowed back in the hostel after the term holiday.** Should these terms not be adhered to and the boarder is sent back to the hostel, she will be kept overnight in the EB Annexe and sent back home the following day, at the expense of the parents. The boarder will be deemed to be in the care of the parents when she boards the bus to her home.
- Please refer to LEGAL ACTION below.
- All payments will **first** be applied to **outstanding school fees** in accordance with the South African Schools Act. Hostel fees, being a separate **contractual liability**, will only be allocated once school fees are settled. The school reserves the right to reallocate payments regardless of the payer's instruction, and unpaid hostel fees may result in withdrawal of accommodation after due notice.

WEEKLY BOARDING

Weekly boarding is offered to learners whose parents live within a range of 20 – 100 kilometres from the school. **The fees for weekly boarding in 2026 are R61 130 per annum.** All arrangements for weekly boarding must be approved by the Principal.

LEGAL ACTION – ALL FEES

- Please note that parents are jointly and severally liable for school and boarding fees.
- Please see above for action in terms of Boarding Fees.
- All accounts are payable in advance. Monthly payments will only be allowed through the School Debit Order system, OR written proof of a Stop Order. Once a parent defaults on any payment, the full amount becomes payable immediately, and a Final Demand will be issued for the full amount.
- School Fee Accounts 90 days in arrears will be handed over to a collection agency and/or the school's lawyers, in accordance with the policies determined by the School Governing Body and the South African Schools Act #84 Section 41.
- When a parent defaults on school and boarding fee payment, action will be taken per the Financial Policy of VGHS.
- In the event of legal action being instituted against a parent(s)/guardians and legal costs do arise, the parent will be held liable for these costs.

DEBIT ORDERS – ALL FEES

Debit Order forms must be completed for monthly payments, unless proof of a Stop Order has been delivered. There are three Debit Order payments runs: on the 1st, 15th or 25th of the month, for your convenience. Should any of these dates fall on a weekend or Public Holiday, the deduction will be made on the first working day thereafter. Any default on monthly payments will be handled as set out under LEGAL ACTION and will result in the boarder being sent home at the cost of the parent.

CAMPS, EXCURSIONS, DANCES, FORMAL SOCIALS AND SOCIALS

- The budgeted cost of the Gr 8–11 camps and excursions and the Gr 12 Matric Dance are included in the school fees.
- All other functions, tours and camps are an optional extra. Full tour/camp fees must be paid by a specified date.
- Parents are advised that the dress code for Formal Socials, such as the Gr 12 Dance, strictly smart casual. Please do not spend money on semi-formal evening wear.

OLYMPIADS & EISTEDDFODS

School fees DO NOT include an allocation towards Olympiad and Eisteddfod entries.

FREE EXEMPTION & ARRANGEMENTS – SCHOOL FEES

- VGHS School Fee Exemption applications are available from the Debtor's Clerk. **No Fee Exemption for hostel fees.**
- Exemption applications must be completed and submitted, including all specified relevant documents for assessment within 30 days of collection.
- Fee Exemption applications must be submitted annually. No applications will be accepted after **30 October**.
- Special arrangements to settle an account in any other way than payment in advance, including specific reasons, must be made annually in writing in January and must be approved by the Finances Committee of the School Governing Body.

NAME BADGES

Lost badges are charged at R35 per badge.

PROVINCIAL REPRESENTATION

In most cases the school is responsible for transport and organisation for provincial trials, but once the girl is selected as part of a team the responsibility of transportation is transferred to parents/guardians.

VGHS TEXTBOOKS

No learner will receive VGHS textbooks or set of notes at the start of the year unless she has returned and/or paid for lost books of the previous year at **R270** per textbook, and **R50** per set of notes. Should a learner have paid for a lost textbook and subsequently return the book in good condition within a month after the payment, she will be refunded.

VGHS OLD GIRLS' UNION

Gr 12 accounts will be debited with a voluntary lifelong membership fee of **R150.00**. Gr 12s have up to the end of the first term to inform the Debtors' Clerk if they do not wish to join the OGU, in which case the account will be credited.

GR 10–12 ART FEES

The Johan Carinus Art Centre is a separate entity with its own staff and School Governing Body. Gr 10–12 VGHS learners taking Art must pay art fees directly to the Johan Carinus Art Centre.

WITHDRAWAL FROM SCHOOL OR HOSTEL

A full month's notice is required, per the *Memorandum of Agreement*. Should the parent fail to, or be unable to give a month's notice, the parent will be liable for all fees and levies for one month ensuing the withdrawal, in addition to any unpaid fees and levies.
